#### **Main Purpose**

To provide safe, high quality play opportunities and care for children, and lead the day to day operation of the after-school club service for children, based at St Martins School, ensuring children can develop personally, socially and educationally, in a safe, caring environment.

The main purpose of your job will be to plan, prepare and deliver a suitable programme of imaginative and innovative activities.

#### Responsibilities

#### **Initial planning**

- To lead in providing a high quality of activities and offer appropriate stimulation and support to the children
- To lead in providing safe, creative, appropriate play opportunities, preparing and organising the activities programme.
- To promote Learning through Play and to encourage play activities organising areas of responsibility on a rota basis

#### Running the club

- Setting up of the venue each day
- To order food and resources
- To provide refreshments for children
- Creating a welcoming and supportive environment for the members of the club
- Managing the behaviour of members of the club
- Tidying of the venue after use.
- Communicating with parent / carers
- Communicating with other school staff
- Administering 1<sup>st</sup> Aid as requested
- Completing 1<sup>st</sup> Aid records as appropriate

#### **Administrative duties**

- Taking the register
- Creating related promotional displays for the club in the school

#### Standards and quality assurance

- Support the aims and ethos of the school
- Set a good example in terms of punctuality, behaviour and attendance
- Ensure the maintenance, cleanliness and safety of equipment
- Maintain appropriate standards of hygiene according to the food standards for schools

#### Other Responsibilities

- Be aware of and comply with policies and procedures relating to child protection, food hygiene, health, safety and security, administration and confidentiality, reporting all concerns to an appropriate person
- Be aware of and support difference and ensure all pupils have equal access to opportunities to learn and develop
- Contribute to the overall ethos/work/aims of the school
- Help to establish constructive relationships and communicate with other agencies/professionals
- Participate in training, other learning activities and performance development as required

- To be prepared to complete both a First Aid and Food Hygiene qualification and complete appropriate records.
